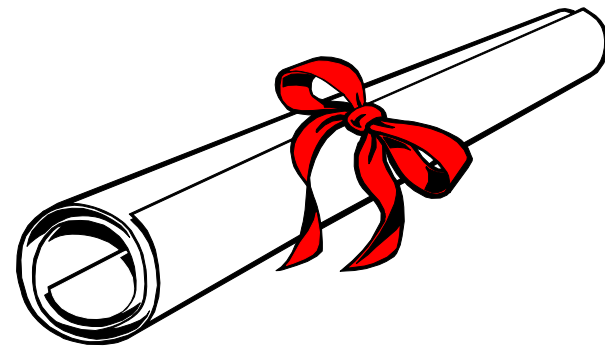

**Scholarships For Graduating
4-H Members Who Pursue
Post-Secondary Education Opportunities**

A Polk County 4-H Scholarship Fund of \$2500 was established by the Polk County 4-H Leaders Federation, Inc. In 1963. This was done in memory of Dale Swenson, a 4-H Peace Corpsman killed in a jeep accident in Brazil. Loans to Polk County 4-H members and alumni pursuing a college education were made from the fund.

A \$500 scholarship plaque was started. Any person, business, or organization contributing \$500 or more to the scholarship fund would have their name and year inscribed on it.

An additional sum was added in 1967 by Gordon Larsen and the Ford Foundation. This was earmarked for farm short course scholarships, adult leaders forum, and member scholarships for national 4-H trips.

Following an analysis of the fund situation in 1985, the Board of Directors of the Polk County 4-H Leaders Federation, Inc., determined the future purpose of the fund should be:

--provide a scholarship with a minimum of two hundred fifty dollars to every member graduating from 4-H in Polk County who is pursuing some type of post-secondary education.

APPLICATION PROCEDURE

1. Only members who graduate from 4-H at the annual Polk County 4-H Awards and Recognition Program in October may apply. To graduate at this event, the member must submit a completed 4-H record book to Polk County 4-H Leaders Federation, Inc. Awards, Recognition and Record Books Committee by the first of September. The record book must contain the MAEF completed by a club advisor.
2. Starting with the 1985 graduates, members graduating from 4-H have five years from date of graduation to make application for their scholarship.
3. Application will include a one-page background information sheet and the completed eight-page 4-H Member Evaluation (ME) forms. These are to be submitted by October 1.
4. Scholarship grant certificates will be presented at the Annual Awards Program in October.
5. Checks will be sent to recipients when proof of enrollment in the second semester or term is submitted.
